I understand that in order for this election to be valid pursuant to law:

1. a. I must have already been a member in a *Police Communications* title (employed by the New York City Police Department as a Police Communications Technician, Supervising Police Communications Technician, or Principal Police Communications Technician) on October 21, 2003, and I must now file an application with NYCERS no later than April 19, 2004 (180 days after enactment of the law)

OR

b. I must have become a member in a *Police Communications* title after October 21, 2003 and file an application with NYCERS within 180 days of becoming a member in a *Police Communications* title (employed by the New York City Police Department as a Police Communications Technician, Supervising Police Communications Technician, or Principal Police Communications Technician)

AND

2. I must be a member in a *Police Communications* title on the date this application is filed with NYCERS
