I Understand That In Order For This Election To Be Valid Pursuant To Law:

1. a.) I must have already been a member in an *Automotive Service* title (excluding Supervisor of Mechanics) on December 12, 2001, and I must now file an application with NYCERS no later than September 9, 2002 (270 days after enactment of the law - December 12, 2001)

OR

b.) I must have become a member in an *Automotive Service* title (excluding Supervisor of Mechanics) after December 12, 2001 and file an application with NYCERS within 270 days of becoming a member in an *Automotive Service* title

OR

c.) I must have already been a member in the title of Supervisor of Mechanics on August 13, 2002, and I must file an application with NYCERS no later than May 12, 2003

OR

d.) I must have become a member in the title of Supervisor of Mechanics after August 13, 2002, and I must file an application within 270 days of my becoming a Supervisor of Mechanics

OR

e.) I must have become a member in the title of Senior Stationary Engineer, Stationary Engineer, Auto Mechanic (Diesel), Auto Electrician, Auto Machinist, Machinist, or Machinist Helper after October 21, 2003, and I must file an application with NYCERS no later than July 15, 2004

I understand that by signing this form and filing it with NYCERS, I am electing to participate in the 25-Year/Age 50 Retirement Program for Tier 2 or Tier 4 Automotive Service titles. I also understand that this election is IRREVOCABLE.
