Improved Benefit Retirement Plan (CPP- I)	55 (50 if in a Physically Taxing Position)	25 years of Career Pension Plan Qualifying Service
Fifty-Five Year Increased Service Fraction Plan (ISF/Plan D)	62 for full benefit, or as early as 55 with reduced benefit	5 years of Credited Service
Age 55 Improved Increased Service Fraction Plan (ISF-I)	55	25 years of Credited Service
Automotive Service Workers 50/25 Plan (AUT-I)	50	25 years of Credited Service
Correction Captains 20 Year Plan (CP-20)	No Age Requirement	20 years of Allowable Correction Service
Correction Officers 20 Year Plan (CI-20)	No Age Requirement	20 years of Allowable Correction Service
Correction Officers Modified 20 Year Plan (P-20)	No Age Requirement	25 years of Allowable Correction Service
DA Investigators 20 Year Plan (20IDA)	No Age Requirement	20 years of Allowable Service as a DA Investigator

Transit Modified 20 Year Retirement Plan (T-20)	50 or 55	25 years (if age 50) or 20 years (if age 55) of Transit Operating Service
Transit Modified One Percent Retirement Plan (1/100)	62 for full benefit, or as early as 55 with reduced benefit	No Minimum
